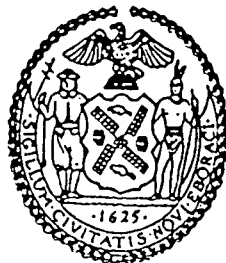

**IN THE MATTER OF** an application submitted by BHW N V Associates pursuant to Sections 1097-c and 200 of the New York City Charter for the **grant of a special permit** pursuant to Sections 13-462 and 74-52 of the Zoning Resolution to **allow an attended public parking lot** with a maximum of 20 spaces on property located on the south side of East 33rd Street between Madison Avenue and Fifth Avenue (Block 862, Lot 69), within a C5-2 District.

Plans for this proposal are on file with the City Planning Commission and may be seen in Room 3N, 22 Reade Street, New York, NY 10007.
