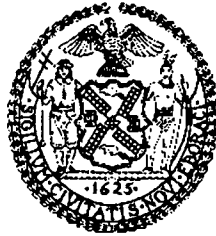

*(Request for the grant of authorizations to remove trees and modify the topography to permit the construction of a health-related facility on a parcel of property within the Special Natural Area District (NA-1) of Staten Island.)*

**IN THE MATTER OF** an application submitted by the Health and Hospitals Corporation pursuant to Sections 105-421, 105-423 and 105-424 of the Zoning Resolution for the grant of authorizations for modification of existing topography, for alteration of botanic environments or removal of trees and for alteration of other natural features at the **Sea View Hospital, located at 460 Brielle Avenue, (Block 955, Lot 170)** to allow the construction of an 18,185 square foot structure to house the Chief Medical Examiner's Office and Morgue, Sea View Hospital Equipment and Emergency Medical Services Ambulance Restocking and Command Center, within the Special Natural Area District (NA-1).
