**CONTINUED PUBLIC HEARING:**

**IN THE MATTER OF the New York City Draft Ten-Year Capital Strategy, pursuant to Section 234 of the New York City Charter, which requires the City Planning Commission to hold a public hearing at which interested individuals and organizations may comment concerning the Draft Ten-Year Capital Strategy.**

The Draft Ten-Year Capital Strategy was issued jointly by the Office of Management and Budget and the Department of City Planning on January 17, 1995, and after a public comment period, will be issued in final form by the Mayor. Issued every two years, the strategy proposes capital commitments to be made during the ensuing years, by program category and agency.
